Ngày 28/02/2011, Cục Quản lý Chất lượng Nông lâm sản và Thủy sản (NAFIQAD) nhận được công thư của Cơ quan Thanh tra và Kiểm dịch nông nghiệp (NAQIA) Papua New Guinea (PNG) về việc NAQIA chính thức cho phép nhập khẩu sản phẩm cá tra/basa fillets đông lạnh Việt Nam, cụ thể:

2. Các Trung tâm Chất lượng nông lâm thủy sản vùng 1-6:

- Phổ biến, hướng dẫn các đoanh nghiệp trên địa bàn thực hiện đúng các nội dung theo yêu cầu của Cơ quan thẩm quyền PNG đối với các lô hàng cá tra/basa fillet đông lạnh xuất khẩu vào thị trường này.

FINAL REPORT

General sanitary measures for importation of basa fillets from Vietnam

This follows a risk analysis process considering potential biosecurity risks associated with the importation of frozen, skinless and boneless fillet meat of pangasid catfish (*Pangasius* spp., basa) from Vietnam into Papua New Guinea.

The aquatic animal health status of PNG is largely undefined as our veterinary and aquatic animal health infrastructure is still developing. However, the environmental health status has been pristine with little influence from exotic diseases and other major economic diseases of fresh water and marine fish. Hence a cautious approach was employed in the risk analysis for importation of basa fillets from Vietnam.

Notwithstanding the disease risks, it is noted that the separation of the fillets from the rest of the carcass effectively removes the majority of organisms that might be present in the live animal. Titres of pathogenic organisms in muscle are usually many times lower than those found in the viscera. It is also considered that the quantities of waste from human consumption of basa fillets are likely to be small and it was apparent that the likelihood of product entering the aquatic environment in sufficient quantities to represent an infectious dose is so low and deemed negligible. In addition, the period of time frozen effectively reduces any parasitic burdens to levels where the likelihood of entry to Papua New Guinea is also negligible. To mitigate any residual risk to human health, water quality standards were specified to prevent entry of foodborne hazards.

Consequently, PNG accepts importation of basa fillets from Vietnam based on the agreed certification protocol as follows.

Permit requirements

- 1. A permit to import must be obtained from the National Agriculture Quarantine and Inspection Authority (NAQIA) of PNG.
- 2. The importer must supply the following information:
 - name and address of the exporter
 - name and address of the export establishment approved by NAFIQAD Vietnam and listed on their website www.nafiqad.gov.vn
- 3. Permits will be issued for single consignments only.

- a. MANUFACTURER'S DECLARATION:
 - Details of dispatched consignment
 - In addition, the following must be declared by the representative of the approved export establishment
